Upon receiving the cancellation form cancellations will take effect for the next system of education not already billed and cancellation forms must be received one week prior to billing date to prevent future billing. All requests for refunds shall be made in writing and/or must accompany returned materials. Returned materials are subject to a 10% restocking fee and no materials older than 60 days will be accepted for a refund. There is no refund on shipping and handling charges. Expect refunds within 4 to 6 weeks.
